AFFIDAVIT OF COMPLIANCE WITH 415 ILCS 5/39.2(d)

CHARLES F. HELSTEN, being first duly sworn on oath, deposes and states as follows:


1. I am an attorney licensed to practice in the State of Illinois with my principal office located at 100 Park Avenue, Rockford, Illinois 61105.
2. I am one of the attorneys for Groot Industries, Inc., and it was my responsibility to prepare, publish and serve the notice of public hearing on the request for approval of a site for a new pollution control facility for a waste transfer station ("Notice") as required in 415 ILCS 5/39.2(d) and Section 160.06(F) of the Village of Round Lake Park Pollution Control Facilities Siting Ordinance.
3. 415 ILCS 5/39.2(d) provides in pertinent part that: "at least one public hearing is to be held by the county board or governing body of the municipality no sooner than 90 days but no later than 120 days after the date on which it received the request for site approval. No later than 14 days prior to such hearing, notice shall be published in a newspaper of general circulation published in the county of the proposed site, and delivered by certified mail to all members of the General Assembly from the district in which the proposed site is located, to the governing authority of every municipality contiguous to the proposed site or contiguous to the municipality in which the proposed site is to be located, to the county board of the county where the proposed site is to be located, if the proposed site is located within the boundaries of a municipality, and to the Agency."


4. The Notice prepared and served in connection with the aforesaid requirement is attached hereto and made a part hereof as Exhibit A. Said Notice conforms to the requirements of Section 39.2(d).
5. I identified the names and addresses of all members of the General Assembly from the legislative district in which the proposed facility is located by using information publicly maintained and available on the Illinois General Assembly internet website (www.ilga.gov).
6. Attorneys supporting me on this project and under my supervision researched and identified those other persons, parties, or entities entitled to notice (i.e., adjacent municipalities, the County and the Illinois Environmental Protection Agency). The municipalities were determined by researching the Lake County map showing municipality boundaries. This information was further verified by phone calls to the City Clerk and Mayor's office for each of these municipalities, as well as to the County Board Chairman of Lake County and the Lake County State's Attorney to identify the current Mayor, City Clerk, County Board Chairman, and State's Attorney and confirm their current business address. These phone calls were made on August 20 and 21, 2013.
7. On August 29, 2013, I caused a search to be performed verifying that there had been no changes within the adjacent municipalities for either the office of Mayor or City Clerk, County Board Chairman or State's Attorney and again confirm their mailing address.
8. I caused a copy of the Notice to be published in the Lake County News Sun, a newspaper of general circulation in the county in which the Application is pending on August 30, 2013. A copy of the actual publication and proof of publication is attached hereto and made a part hereof as Exhibit B.

9. Attached hereto and made a part hereof as Exhibit C is the full and complete list of all individuals and entities which were served the Notice pursuant to 415 ILCS 5/39.2(d). This includes all City Clerks, Mayors, County Board Chairman, State's Attorney, Illinois Environmental Protection Agency, and members of the General Assembly who were entitled to Notice.
10. On August 29, 2013, certified mail Notices were sent to all individuals and entities set forth on Exhibit C. The original certified mail receipts for all Notices are attached hereto and made a part hereof as Exhibit D.
11. On August 29, 2013, a Notice was sent to all individuals and entities set forth on Exhibit C by regular mail in addition to the certified noted in item (9) above.
12. The site Application which is the subject of the Notice herein was filed on June 21, 2013.
13. All of the foregoing complies fully and completely with the notice of hearing requirements of 415 ILCS 5/39.2(d).
