A policy or certificate of insurance, issued by a company licensed to do business in the State of Illinois and acceptable to Lake County, showing proof of insurance as required below shall be submitted with this completed License Application. All such policies or certificates of insurance shall be in a form acceptable to the State's Attorney. The licensee shall maintain the full insurance coverage required herein at all times and a duplicate certificate of insurance shall be deposited with the County Clerk and shall provide that such insurance may not be canceled except upon 30 days prior written notice to the County Clerk.

- i) Workman's Compensation Insurance with a company authorized under the laws of the State of Illinois with a policy to protect itself against liability under the Workers' Compensation Act and the Workers' Occupational Diseases Act of the State of Illinois.
- ii) Vehicle Liability Insurance under a comprehensive policy to insure the entire vehicle fleet liability for its operations with limits of not less than \$3,000,000 each person and \$3,000,000 each accident bodily injury liability, \$1,000,000 each accident for property damage liability.
- iii) General Liability under a comprehensive liability policy for its operations other than vehicular operations with limits of at least \$1,000,000 each person and \$3,000,000 each accident for bodily injury liability, \$1,000,000 each accident for property damage liability.

The Applicant certifies the following statements to be true:

- 1. Yes No Said Applicant and/or Applicant's Company while operating in Lake County, under the terms of the Lake County Solid Waste Hauling and Recycling Ordinance, offers the service of collecting Municipal Waste and Recyclable Materials to any individual resident, single-family home, multi-family home, commercial business or institutional facility within the County.

Municipal Waste means garbage, general household institutional and commercial waste, industrial lunchroom or office waste and construction and demolition debris waste.

Recyclable Materials means materials that are separated from Municipal Waste for the purpose of recycling, including but not limited to, ferrous metal cans, aluminum containers, glass, plastic, which shall include HDPE, PET containers and plastics #3 through #7, newsprint, corrugated paper, junk mail, magazines, office paper and boxboard.

- 2. Yes No Said Applicant and/or Applicant's Company while operating within the unincorporated area of Lake County, under the terms of the Lake County Solid Waste Hauling and Recycling Ordinance, offers to all residential customers Volume-Based Pricing, utilizing either graduated container option with the price of service increasing as the size of the waste container increases or a limited waste disposal program such as a sticker or extra charge for collecting waste in excess of their container capacity.

Volume Based Pricing means a system under which residents pay for municipal waste management and disposal services by weight or volume collected, not a fixed fee.
- 3. Yes No Said Applicant and/or Applicant's Company while operating in Lake County, under the terms of the Lake County Solid Waste Hauling and Recycling Ordinance, provides as part of basic service, the collection of Recyclable Materials from all single family homes at least once every two weeks.
- 4. Yes No Said Applicant and/or Applicant's Company while operating in Lake County, under the terms of the Lake County Recycling Ordinance provides their customers information on how and what materials to recycle at least once every other year.
- 5. Yes No Said Applicant and/or Applicant's Company while operating in the unincorporated area of Lake County, under the terms of the Lake County Recycling Ordinance, provides a written offer to provide recycling service to commercial businesses or institutional facilities that are not recycling. The written offer is made at least once during the term of their contract or in the absences of a contract at least once every two year, whichever is shorter. The written offer made by the Applicant and/or Applicant's Company includes a request that the commercial business or institutional facility respond in writing.
- 6. Yes No Said Applicant and/or Applicant's Company shall comply with Section 3.6 of the Lake County Recycling Ordinance providing reports on its solid waste, recycling and landscape waste collections on or before July 31 and January 31 of each year (reporting form included in application packet).
- 7. Yes No Said Applicant and/or Applicant's Company is not judged in Default on any matter as it pertains to the County of Lake;
- 8. Yes No Said Applicant and/or Applicant's Company shall conduct business in accordance with all ordinances and regulations of Lake County;
- 9. Yes No Said Applicant and/or Applicant's Company certify that equipment used in conducting the Applicant's business meet all requirements of ordinances and regulations of the County of Lake;
- 10. Yes No Said Applicant and/or Applicant's Company certify that all aforementioned information submitted is truthful and accurate;
