#### CALL TO ORDER

Chairperson Michael Talbott called the meeting to order at 12:01 pm with 6 members in attendance.  
*Derke Price in attendance. John Norris connected via telephone. Drew Irwin of Lake Bluff in attendance.*

1. **Proposed FY 2024 SWALCO Budget**

Walter Willis presented the proposed FY 2024 budget, highlighting proposed expenditures and estimated revenues including the reviews of the cash replacement and cash balance funds. Walter presented and discussed data tables as presented in packet.

Motion by *Mike Ellis*, seconded by *John Wagener* to adopt the FY2024 Budget and will be presented to full board in November for approval. *Motion was unanimously approved.*

2. **Sharps Vendor Agreement**

Joe Martino and Walter Willis presented the approved sharps vendor agreement with American RX. Joe presented and discussed the program items and proposal.

Motion by *Jenny Ross*, seconded by *Pat Muetz* to adopt the agreement with American RX.  
*Motion was approved on a roll call vote of 7 to 0.*

#### INFORMATION ITEMS

1. **Updates & Info from Programs and Education**

Highlights and noteworthy information for Members on Programs, Events, Outreach and Education.

2. **Project and Program Updates – Brief Updates Given by Walter Willis**

Walter Willis provided **summaries** and updates regarding several projects and programs we are currently working on:

- The complaints against the landfills continue, Walter Willis has a deposition scheduled for November 15, 2023.
- The MRF proposals were due on October 13<sup>th</sup> and will be discussed generally at the meeting. APTIM is preparing a white paper on the project that will be sent to all members later this month in anticipation of the BOD meeting on November 16<sup>th</sup> where staff may recommend entering into a contract with the preferred vendor.
- Pete and Walter met with Reynolds Consumer Products in Lake Forest on October 5<sup>th</sup> to discuss a possible launch of a Hefty ReNew bag program in Lake County. Under this program, difficult to recycle plastics such as film, chip bags, pet food bags, stryrofoam, etc. can be placed into an orange bag made by Hefty/Reynolds and put into the recycling cart. Discussions will continue but a willing MRF must be found that will sort and bale the bags for delivery to downstream markets. Reynolds has this program up and running in about 6 or 7 other locations across the U.S.
- SWALCO is working on several battery related initiatives. The IEPA has informed us that it has been selected to submit a formal proposal to the U.S. Department of Energy to obtain a grant to collect more battery types at our HCW facility. DOE has a significant grant program that would cover our costs to accept and manage more battery chemistries. Second, we have teamed with the collar counties, Metro Mayors Caucus and IRMA to obtain another DOE grant focused on battery collection education. This grant would be for several million dollars and would allow for a formal marketing campaign and ads to be developed to increase knowledge of why and how to recycle different types of batteries. Finally, SWALCO is on a team that is meeting with IMA, IRMA, the waste industry and local government to develop a battery EPR law that may be filed in 2024 if we can get agreement among the parties. We are also engaged with the battery industry's main association, the Rechargeable Battery Association, which for the most part is supportive of EPR laws.

**A – 1. SWANCC IGA HCW Event Agreement**

**ISSUE:** Whether to recommend approval of an Intergovernmental Agreement (IGA) with the Solid Waste Agency of Northern Cook County (SWANCC) including the terms for hosting a Household Chemical Waste (HCW) event in Skokie, IL.

**RECOMMENDATION:** Staff recommend that the Executive Committee approve the IGA with SWANCC.

Attachment A is the agreement with SWANCC, which outlines each Agency's roles and responsibilities. Notably, SWANCC would pay for almost all the costs associated with the event, including labor, food, and operation equipment. SWALCO would provide insurance, management for the event, as well as storage for the waste at the SWALCO facility until pickup. Attachment B is email correspondence confirming our insurance coverage area, confirming it would be applicable to Cook County.

The event would be held on June 22<sup>nd</sup>, 2024, at Westfield Old Orchard Mall, located at 4905 Old Orchard Center, Skokie, IL 60077.

**INTERGOVERNMENTAL AGREEMENT**  
**BETWEEN THE SOLID WASTE AGENCY OF NORTHERN COOK COUNTY**  
**AND THE SOLID WASTE AGENCY OF LAKE COUNTY**  
**FOR THE HOSTING OF EVENTS FOR THE COLLECTION**  
**OF HOUSEHOLD HAZARDOUS WASTE**

**THIS AGREEMENT** is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_ 2024, by and between the Solid Waste Agency of Northern Cook County, an Illinois statutory solid waste agency (“SWANCC”), and the Solid Waste Agency of Lake County, an Illinois statutory solid waste agency (“SWALCO”), collectively hereinafter referred to as the “Parties”; and

**WHEREAS**, Article VII, Section 10 of the Illinois Constitution of 1970 provides that units of local government may contract or otherwise associate among themselves to obtain or share services and to exercise, combine or transfer any power or function in any manner not prohibited by law or by ordinance and may use their credit, revenues and other resources to pay costs related to intergovernmental activities; and

**WHEREAS**, the Illinois Intergovernmental Cooperation Act, 5 ILCS 220/1 *et seq.* further authorizes intergovernmental cooperation; and

**WHEREAS**, SWALCO has entered into a contract with the Illinois Environmental Protection Act (“IEPA”) under which SWALCO conducts events at which the public may deliver household hazardous waste (as defined by the Illinois Environmental Protection Act) (“HHW”) to SWALCO’s contractor for proper disposal; and

**WHEREAS**, SWALCO conducts these HHW events over the course of a calendar year at different locations throughout Lake County; and

**WHEREAS**, through their statutory powers of intergovernmental cooperation, SWANCC desires to contract with SWALCO to conduct HHW events at locations sponsored by SWANCC’s member municipalities on dates that are mutually acceptable to SWALCO and SWANCC; and

**WHEREAS**, SWANCC will pay SWALCO (and its contractors) for the costs associated with the HHW event at SWANCC member communities; and

**WHEREAS**, the Parties desire to memorialize terms in this master agreement providing the terms to apply to specific HHW events to be scheduled by the parties; and

**WHEREAS**, each of the Parties finds it to be in the best interests of their respective Agencies to enter into this Agreement.

**NOW THEREFORE** for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, SWANCC and SWALCO agree as follows:

**1. Incorporation of Preambles.** The Preambles set forth above are hereby incorporated by this reference into this Agreement as though they were restated in their entirety in this Section 1.

**2. Scheduling of HHW Events.** During such period of time as SWALCO shall be authorized by IEPA to conduct HHW Events, SWANCC may request SWALCO to conduct one or more HHW Events at locations and dates as shall be mutually agreed by the Parties. The Parties' Agreement on such dates and locations for HHW Events may be memorialized by countersigned letter agreements without further amendment of this Agreement.

**3. Administration and Operation of the HHW Event.** For all agreed HHW Events to be conducted for SWANCC, SWALCO shall administer and operate the HHW Event. SWALCO's duties include oversight, coordination, site logistics, traffic control, general conditions (e.g., portable toilets) and also for arranging for the collection, transportation and disposal of the HHW in accordance with its IEPA contract and the Act. SWANCC shall be responsible to provide the publicity for the HHW Event and to facilitate communication between the sponsoring community and SWALCO.

**Insurance.** SWALCO shall provide insurance, including pollution coverage endorsements, for HHW Events and shall be required by SWANCC to list SWANCC as an additional insured. This insurance shall not be primary to that of SWALCO's selected vendor contractors and shall be non-contributory. SWALCO shall require its vendor contractors to name SWANCC as an additional insured and certificate holder and such insurance of the vendor contractors shall be primary to any insurance of SWANCC.

**4. Costs.** For purposes of this Agreement, "Costs" shall include the direct costs incurred by SWALCO from its vendor contractors for each HHW Event conducted for SWANCC. Costs do not include the costs of SWALCO employees. SWALCO shall, within 90 days of each HHW Event SWALCO conducts for SWANCC, submit to SWANCC itemized invoices with supporting documentation for the costs incurred by SWALCO for which SWANCC is responsible to pay SWALCO. SWANCC shall remit payment to SWALCO within 45 days of receipt of each invoice.

**5. Compliance with Laws.** The Parties shall abide by all laws with respect to the HHW Events.

**6. Indemnification.** Each Party shall indemnify and hold harmless the other Party, including its elected officials in either their official or individual capacity, and its officers, employees, volunteers and agents, from and against all claims, damages, losses and expenses, including but not limited to legal fees (attorney's and paralegals' fees and court costs), arising from or in any way connected with any wrongful or negligent act or

omission of that particular Party, including its officers, officials, employees, agents, students and volunteers, except to the extent it is caused in part by a party indemnified hereunder.

7. **Termination.** Either Party may terminate this Agreement upon no less than 30 days notice following any mutually agreed and scheduled HHW Events.

8. **No Duty to Third Parties.** This Agreement is entered into solely for the benefit of the Parties, and nothing in this Agreement is intended, either expressly or impliedly, to provide any right or benefit of any kind whatsoever to any person and entity who is not a party to this Agreement or to acknowledge, establish, or impose any legal duty to any third party. Nothing herein shall be construed as an express and/or implied waiver of any common law and/or statutory immunities and/or privileges of the Parties and/or any of their respective officials, officers, and/or employees.

9. **No other Relationship.** Nothing contained in or done pursuant to this Agreement shall be construed as creating a partnership, agency, joint employer or joint venture relationship between the parties. Except as otherwise expressly provided for in this Agreement, neither party shall become bound, with respect to third parties, by any representation, act or omission of the other party.

10. **Representations and Warranties.** Neither party makes any representations or warranties, except as specifically set forth in this Agreement.

11. **Counterparts.** This Agreement may be executed in Counterparts, each of which shall constitute an original, but altogether shall constitute one and the same Agreement.

12. **Severability.** It is mutually understood and agreed that all agreements and covenants herein are severable and that in the event any of them shall be held to be invalid by any Court of competent jurisdiction, this Agreement shall be interpreted as if such invalid agreement or covenant were not contained herein.

13. **Modification.** The agreements, covenants, terms and conditions herein contained may be modified only through the written mutual consent of the parties hereto.

14. **Entire Agreement.** This Agreement sets forth all the covenants, conditions, and promises between the Parties. There are no covenants, promises, agreements, conditions, or understandings between the Parties, either oral or written, other than those contained in this Agreement.

15. **No Waiver.** The Parties do not waive or release any claims that they may have in the future against any other party. The failure of any party to this Agreement to enforce the provisions of this Agreement or require performance by an opponent of any of the provisions shall not be construed as a waiver of such provisions or affect the right of claimant to thereafter enforce the provisions of this Agreement. Waiver of any breach of

this Agreement shall not be held to be a waiver of any other or subsequent breach of this Agreement.

**16. Notice.** Any and all notices required to be delivered hereunder shall be deemed delivered when and if personally delivered, or mailed by registered or certified mail, return receipt requested, postage prepaid (or sent by recognized overnight carrier service with instructions and payment for delivery on the next business day), or by email with a read-receipt, or by facsimile transmission during regular business hours, to the respective Executive Directors of the Parties.

Pursuant to our recent discussions, I've prepared this letter of engagement to memorialize a new, 2-year contract to provide legislative consulting services on behalf of the Solid Waste Agency of Lake County ("SWALCO"). If this agreement is acceptable to you, please execute a copy and return it to me.

1. **Parties to the Agreement.** The parties to this agreement are the Strategic Advocacy Group, referred to herein as "Contractor", and SWALCO.
2. **Term and Duties.** The term of this agreement shall be for the period December 1, 2023 to November 30, 2025. Upon the date that this agreement becomes effective, it shall replace all prior contractual agreements between the two parties

During the term, Contractor shall provide legislative consulting services. **BACKGROUND:** Under IL law counties are required to update their solid waste management plans every 5 years, Lake County's plan update is due in 2024. The same law authorizes joint action agencies like SWALCO to prepare the plan and plan updates but to become effective, the County Board must adopt it.

We have worked with APTIM over the past several plan updates and they are well aware of the scope of work we need to collect, collate and present all the data we collect. They will also assist with developing the policy portions of the plan. We will be appointing a Citizens Advisory Committee as we have in the past to assist with the preparation of the plan update. The CAC will be appointed at the April 11<sup>th</sup> BOD meeting.

This plan update I plan to shorten in length significantly from past plan updates. More focus will be on the policy for the next five years. We will continue to present all the data we have in past plan updates due to the importance of this data in tracking and evaluating our progress. The goal will be to have the SWALCO board adopt the plan update in October and then move it to the Lake County Board for approval in November or December.

ApTim Environmental & Infrastructure, LLC. (APTIM) is pleased to provide this proposal to assist the Solid Waste Agency of Lake County (SWALCO) in the development of its 2024 Solid Waste Management Plan Update including updating demographic information, projecting waste and recycling quantities for the upcoming planning period, assisting in drafting policy recommendations, compiling data into a draft report for the 2024 Plan Update, and participating in meetings.

#### **Scope of Services**

1. **Demographic Information Update:** APTIM will refresh population, household, and employment data in the 2024 Plan Update using projections from Lake County and regional planning agencies. This updated demographic information will then inform forecasts of future waste and recycling quantities for Lake County.
2. **Waste and Recycling Quantity Estimates:** APTIM will develop current estimates of waste and recycling quantities utilizing the most recent year of data available. We will follow the methodology utilized in the 60% Recycling Goal Report and the most recent plan update, utilizing residential tonnage data reported by communities throughout the County, commercial and construction/demolition debris tonnage data reported through the County's Hauler Licensing Ordinance, and Lake County waste disposal quantities reported by the in-county landfills. This data, in conjunction with the demographic projections previously compiled, will be utilized to calculate current per capita rates to assess progress towards goals established in the 60% Recycling Goal Report and to prepare projections of future material quantities to be managed.
3. **Policy Section Collaboration:** APTIM will work closely with SWALCO staff to develop report sections on policy recommendations. This includes drafting policy recommendations for the upcoming planning period and evaluating the implementation status of recommendations from the 2019 plan update.
4. **Data Compilation:** Demographics, waste and recycling quantities, and per capita rates will be compiled into a draft report to be included as a chapter in the 2024 Plan Update.
5. **Meeting Engagement:** APTIM commits to attending four meetings: one kickoff meeting with SWALCO staff, two advisory committee meetings (if SWALCO forms an advisory committee), and one meeting to present the plan to the SWALCO Board.

6. **Final Report Compilation:** In conjunction with SWALCO Staff, APTIM will prepare and compile the 2024 Plan Update report in both Microsoft Word and PDF formats. A draft report will be provided to SWALCO staff. APTIM will then incorporate comments from SWALCO staff and the Citizen's Advisory Committee into the report.

#### Schedule and Budget

APTIM proposes to complete the above scope of services for a budget of \$38,000. Project costs will be billed on a time and materials basis in accordance with our standard fee schedule (attached). The proposed budget will not be exceeded without prior authorization from SWALCO. Work is proposed to be completed in accordance with the terms of our standard form Professional Services Agreement (PSA), which is attached for your review. If these terms are acceptable, please sign and return the PSA to me for execution. A copy of the PSA will be returned for your files and will serve as our notice to proceed.

If notice to proceed is received in February, APTIM will complete a draft for SWALCO staff in August of 2024, such that there will be four months remaining in the year to bring the report before advisory committee(s), the SWALCO Board, and the County Board.

## **PROFESSIONAL SERVICES AGREEMENT**

This Agreement by and between Aptim Environmental & Infrastructure, LLC. ("APTIM"), and the undersigned client ("CLIENT") sets forth the terms and conditions pursuant to which APTIM will provide services (the "Services") to CLIENT.

### **1. Services**

The Services to be performed are as described in Proposal for 2024 Solid Waste Management Plan Update Assistance, which is attached as Exhibit A. The parties may modify, supplement or change the Services to be performed only by written amendment to Exhibit A.

### **2. Compensation**

Unless otherwise stated in Exhibit A, the Services will be performed on a time and materials basis, in accordance with APTIM's time and material rates in effect at the time that the Services are performed. A copy of APTIM's current Time & Material Rate Sheet is attached as Exhibit B. APTIM may modify the rates at the end of a calendar year.

If Exhibit A contains an estimate of the total charges for the performance of the Services, such estimate shall not be treated as a not-to-exceed cap or guaranteed maximum price for the Services, unless Exhibit A explicitly states that such estimate constitutes a not-to-exceed cap or guaranteed maximum price. Any not-to-exceed cap or guaranteed maximum price shall be subject to adjustment in the event of modifications, supplements or other changes to the Services, unforeseen, differing or changed conditions or circumstances, or other conditions or circumstances beyond APTIM's reasonable control.

### **3. Payment**

Unless otherwise agreed to in writing, invoices will be submitted no more frequently than every two weeks. Invoices shall be paid in U.S. Dollars in the manner requested by APTIM and are due upon receipt. Invoices not paid within thirty (30) days after the date thereof shall bear interest from the date thereof at the rate of one and one-half (1-1/2) percent per month or the maximum rate permissible by law, whichever is less.

### **4. Termination**

Either Party may terminate this Agreement at any time, with or without cause, by written notice; provided, however, that CLIENT shall compensate APTIM for all Services performed prior to APTIM's actual receipt of notice and all of APTIM's costs and expenses incurred prior to and/or as a result of the termination.

### **5. Independent Contractor**

APTIM shall be fully independent in performing the Services and shall not act as an agent or employee of CLIENT.

### **6. Taxes, Fees, and Other Charges**

In connection with the Services, CLIENT shall pay all sales, conveyance, transfer and recording fees and taxes, if any. In the event APTIM is requested or authorized by CLIENT, or is required by government regulation, subpoena, or other legal process, to produce documents or personnel as witnesses regarding the Services performed under this Agreement, CLIENT agrees, so long as APTIM is not a party to the proceeding in which the information is sought, to reimburse APTIM for its professional time and expenses, as well as the fees and expenses of counsel, incurred in responding to such requests.

### **7. Documentation, Records, Audit**

All documents, records, data, laboratory or field equipment computerized data files, computer models or other information supplied to APTIM by CLIENT and/or CLIENT's agents, employees, directors, officers, shareholders, or representatives shall remain the property of CLIENT and shall be returned to CLIENT upon completion of any work or service provided hereunder. APTIM shall be permitted to retain a copy of such information for archival purposes.

CLIENT shall have the right, at its expense, to inspect and audit APTIM's records and accounts covering charges hereunder at all reasonable times during the course of the Services for a period of one (1) year after the substantial completion thereof; provided, however, that the purpose of such audit shall be only for verification of such charges. APTIM is not required to keep records, or provide access to records it may have, relating to costs of goods or services charged to CLIENT on the basis of a fixed price, fixed unit rates, or which are expressed in terms of percentages of other costs.

Upon completion of any such audit, the results shall be presented to APTIM. To the extent that the audit indicates that APTIM has not been adequately compensated by CLIENT, CLIENT shall pay APTIM any compensation due as shown by the audit. Alternatively, to the extent that any audit indicates that the total amount of compensation paid by CLIENT to APTIM exceeded the actual amount due, APTIM shall return such excess compensation to CLIENT.

### **8. APTIM's Responsibilities**

a. APTIM shall perform its services consistent with the professional skill and care ordinarily provided by members of the same profession practicing at the same time in the same or similar locality under the same or similar circumstances. APTIM makes no warranties, express or implied, under this Agreement or otherwise, in connection with the Services, and nothing stated in this Agreement shall be interpreted to require APTIM to exercise professional skill and care greater than that required in this Section 8a.

b. APTIM will complete the Services within a reasonable time. If a specific schedule is required by CLIENT, it must be set forth on Exhibit A. Except to the extent resulting from the fault of APTIM, if the provision of the Services is delayed or impaired, the time for completion

of the Services shall be extended appropriately, and the rates and amounts of APTIM's compensation shall be adjusted equitably.

c. If the Services require APTIM to estimate the cost of work to be performed by others, such estimate shall be made on the basis of APTIM's experience and qualifications and shall represent APTIM's best judgment as an experienced and qualified professional. However, since APTIM has no control over the cost of labor, materials, equipment, or services furnished by others, or over contractors' methods of determining prices, or over competitive bidding or market conditions, APTIM cannot and does not guarantee that proposals, bids, or actual costs of such other work will not vary from APTIM's estimate. If CLIENT wishes greater assurance as to probable cost, CLIENT may employ an independent cost estimator.

## **9. Client Cooperation**

CLIENT will: (a) provide APTIM with all relevant information available to it concerning the project or activity in connection with which the Services are requested; (b) consult with APTIM when requested; (c) provide APTIM with reasonable access to relevant sites; (d) make decisions and carry out its other responsibilities in a timely manner so as not to delay the performance of the Services; and (e) notify and report to regulatory agencies or governmental officials as required. CLIENT shall be responsible for, and APTIM may rely upon, the accuracy and completeness of all requirements, programs, instructions, reports, data, and other information furnished by CLIENT to APTIM relating to the Services. APTIM may use such requirements, programs, instructions, reports, data, and information in performing the Services.

## **10. Indemnity**

**(2) LEARNS OF FACTS (OTHER THAN THE KNOWLEDGE APTIM GAINS THROUGH PERFORMING THE SERVICES) THAT MAY GIVE RISE TO A DUTY BY INDEMNITOR TO DEFEND, TO INDEMNIFY, OR HOLD HARMLESS,**

**THE INDEMNITEE SHALL PROMPTLY PROVIDE WRITTEN NOTICE TO THE INDEMNITOR. FAILURE TO PROVIDE PROMPT NOTICE WILL CONSTITUTE A WAIVER OF ANY INDEMNITY RIGHTS TO THE EXTENT THAT SUCH FAILURE UNDERMINES INDEMNITOR'S ABILITY TO MITIGATE ITS EXPOSURE.**

## **11. Defects in the Services**

a. CLIENT shall not be responsible for discovering deficiencies in the technical accuracy of APTIM's services; however, should CLIENT become aware of such a deficiency, CLIENT shall promptly notify APTIM in

writing. APTIM shall correct any such deficiencies in technical accuracy without additional compensation except to the extent such corrective action is attributable to deficiencies in CLIENT-furnished information.

b. In the event of any defect in any Service that does not cause damage to persons or property, APTIM's sole responsibility shall be to either (a) re-perform any defective Service according to the scope of work for that Service, or (b) to commence and diligently pursue the cure of the defect. Such re-performance or cure shall be CLIENT's sole and exclusive remedy for a defect covered by this paragraph.

## **12. Limitation of Liability**

CLIENT hereby acknowledges, understands and agrees that: (1) there are risks inherent in the Services, many of which cannot be ascertained or anticipated prior to or during the course of the Services; (2) due to the inherently limited nature and amount of the data resulting from investigation methods, complete analysis of conditions is not always possible, and, therefore, conditions frequently vary from those anticipated earlier; for example, borings in one location may not reveal contaminants only a few feet away; and (3) technology, methods, accepted professional standards as well as law and policy, are constantly changing and evolving. In light of all of the foregoing and APTIM's lack of responsibility for creating the conditions requiring the Services, as a material inducement to and consideration for APTIM's agreement to perform the Services on the terms and at the price herein provided for,

**TO THE MAXIMUM EXTENT PERMITTED BY LAW, CLIENT SPECIFICALLY AGREES THAT, NOTWITHSTANDING ANY OTHER PROVISION CONTAINED IN THIS AGREEMENT, FOR ALL LOSSES, DAMAGES, LIABILITIES OR EXPENSES (INCLUDING ATTORNEYS' FEES AND COSTS) ARISING OUT OF OR RELATED TO THIS AGREEMENT OR THE SERVICES, WHETHER BASED IN CONTRACT, TORT, INDEMNITY, OR ANY OTHER CAUSE OF ACTION OR THEORY ("CLAIM"), APTIM'S LIABILITY (INCLUDING THE LIABILITY OF ITS INSURERS, EMPLOYEES, AGENTS, DIRECTORS, AND OFFICERS AND ALL OTHER PERSONS FOR WHOM APTIM IS LEGALLY RESPONSIBLE) SHALL NOT EXCEED IN THE CUMULATIVE AGGREGATE WITH RESPECT TO ALL CLAIMS THE LESSER OF THE TOTAL AMOUNT OF COMPENSATION PAID TO APTIM HEREUNDER OR \$100,000.**

## **13. Waiver of Consequential Damages**

**IN NO EVENT SHALL APTIM OR CLIENT BE RESPONSIBLE FOR ANY INCIDENTAL, INDIRECT, SPECIAL, OR CONSEQUENTIAL DAMAGES (INCLUDING BUT NOT LIMITED TO LOSS OF PROFITS, LOSS OF REVENUE, LOSS OF USE, LOSS OF OPERATION TIME, LOSS OF PRODUCT OR BUSINESS INTERRUPTION, HOWSOEVER CAUSED), WHETHER KNOWN OR UNKNOWN, FORESEEABLE OR UNFORESEEABLE, ARISING FROM OR RELATED TO THIS AGREEMENT OR**

**THE SERVICES, REGARDLESS OF WHETHER SUCH DAMAGES ARE PREMISED ON A THEORY OF TORT, STRICT LIABILITY, INDEMNITY, WARRANTY, PROFESSIONAL LIABILITY, CONTRIBUTION, EQUITY, OR OTHERWISE.**

## **14. Insurance**

APTIM is presently protected by Worker's Compensation Insurance as required by applicable law and by General Liability and Automobile Liability Insurance (in the amount of \$1,000,000 combined single limit) for bodily injury and property damage. Insurance certificates will be furnished on request. If CLIENT requires additional insurance coverage, APTIM will endeavor to obtain said coverage, and CLIENT shall be charged therefor.

## **15. Intellectual Property, Patents and Inventions**

CLIENT may use any final reports of findings, feasibility studies, industrial hygiene and safety, engineering work or other work performed or prepared by APTIM under this Agreement for its internal purposes in connection with the project and/or location for which such work was prepared, but APTIM reserves all other rights with respect to these and all other documents produced in performing the Services. All reports will be delivered subject to APTIM's then current limitations. CLIENT shall obtain prior written consent from APTIM for any other use, distribution, or publication of such reports or work results.

APTIM shall retain all right and title to all patentable and unpatentable inventions, including confidential know-how, developed by APTIM hereunder in APTIM's field of expertise. APTIM shall grant to CLIENT a royalty-free, nonexclusive and nontransferable license under any such developed inventions and know-how to use the same in any of CLIENT'S facilities.

APTIM shall endeavor to provide Services in a manner that does not infringe on any valid patent, copyright, trademark or involve the use of any confidential information that is the property of others unless APTIM is licensed or otherwise has the right to use and dispose thereof. APTIM shall also inform CLIENT of any infringement that it has actual knowledge of a reason to expect will result from the use of the Services. However, APTIM shall not be required to conduct and/or prepare a patent or other search and/or opinion. Information submitted by APTIM to CLIENT hereunder is not intended nor shall such submission constitute inducement and/or contribution to infringe on any patent(s) owned by a third party, and APTIM specifically disclaims any liability therefor.

## **16. Confidentiality**

In the course of performing Services, to the extent that CLIENT discloses to APTIM, or APTIM otherwise acquires, business or technical information that CLIENT clearly marks as confidential or proprietary, APTIM will exercise reasonable efforts to avoid the disclosure of such information to others. APTIM will not use such information for any purpose other than the performance of Services to CLIENT.

CLIENT shall treat as confidential all information and data furnished to it by APTIM in connection with this Agreement including, but not limited to, APTIM's technology, formulas, procedures, processes, methods, trade secrets, ideas, inventions, and/or computer programs; and CLIENT shall not disclose such information to any third party, except to a related company that has first agreed in writing with APTIM to an obligation of confidentiality identical to the obligations of CLIENT as set forth herein.

However, nothing herein is meant to prevent nor shall it be interpreted as preventing either APTIM or CLIENT from disclosing and/or using said information or data (i) when the information or data is actually known to the receiving party before being obtained or derived from the transmitting party; or (ii) when, at any time, the information or data is generally available to the public without the receiving party's fault; or (iii) when the information or data is obtained or acquired in good faith at any time by the receiving party from a third party; or (iv) when a written release is obtained by the receiving party from the transmitting party; or (v) three (3) years from the date of receipt of such information; (v) or when permitted by this Agreement; or (vi) when required by process of law; provided, however, upon service of such process and to the extent practical and permitted by law, the recipient thereof shall promptly notify the other party so that they may object to the disclosure and/or waive compliance with the terms of this Agreement.

CLIENT shall obtain APTIM's prior consent and cooperation with the formulation and release of any public disclosure in connection with this Agreement or work performed hereunder, before issuing a news release, public announcement, advertisement, or other form of publicity.

## **17. Assignment**

Neither party shall assign any right or delegate any duty under this Agreement without the prior written consent of the other. Notwithstanding the foregoing, any parent, subsidiary or affiliate of APTIM may perform some or all of the Services, and APTIM may upon notice to the CLIENT assign, pledge or otherwise hypothecate the cash proceeds and accounts receivable resulting from the performance of any Services or sale of any goods pursuant to this Agreement. Subject to the foregoing, this Agreement shall inure to the benefit of, and be binding upon, the parties' respective successors and assigns.

## **18. No Third Party Beneficiaries**

This Agreement is strictly for the benefit of APTIM and CLIENT. There are no third-party beneficiaries to this Agreement, and no one other than APTIM and CLIENT may seek to enforce it. This Agreement is not intended to create any obligations owed to third parties.

## **19. Disputes and Arbitration**

a. APTIM and CLIENT shall negotiate for a period of 30 days from notice of any dispute relating to this Agreement or the Services.

b. If the parties fail to resolve a dispute by direct negotiation, the dispute shall be resolved by binding

arbitration in Baton Rouge, Louisiana. The arbitration shall be administered by the American Arbitration Association in accordance with its Commercial Arbitration Rules then in effect. A demand for arbitration shall be made in writing, delivered to the other party to this Agreement, and filed with the American Arbitration Association. The party filing a demand for arbitration must assert all disputes and claims then known to that party relating to this Agreement or the Services. The responding party must include in its response all disputes and claims then known to that party relating to this Agreement or the Services. The arbitrator shall limit discovery to the exchange of documents relevant to this Agreement and the Services and to a limited number of depositions based on the size and complexity of the dispute. Interrogatories and requests for admissions are not permitted. The award rendered by the arbitrator shall be final, and judgment may be entered thereon by any court having jurisdiction.

c. The prevailing party, if any, shall be entitled to recover as damages its reasonable legal fees and expenses incurred in the course of the arbitration. A prevailing party is a party whose outcome is better for that party than that stated in the most recent written settlement offer made by that party at least 30 days prior to the beginning of the arbitration hearing.

## **20. Governing Law**

This Agreement shall be governed by and interpreted pursuant to the rules of the state where the Services are performed. In the case of Services consisting mostly of engineering and consulting performed at APTIM's offices, this shall be the state in which the APTIM office principally responsible for the Services is located.

## **21. Entire Agreement**

The terms and conditions set forth herein, and the exhibits hereto, constitute the entire understanding of the parties relating to the provision of Services by APTIM to CLIENT. This Agreement may be amended only by a written instrument signed by both parties.

## **22. Waiver of Terms and Conditions**

The failure of APTIM or CLIENT in any one or more instances to enforce one or more of the terms or conditions of this Agreement or to exercise any right or privilege in this Agreement or the waiver of any breach of the terms or conditions of this Agreement shall not be construed as thereafter waiving any such terms, conditions, rights, or privileges, and the same shall continue and remain in force and effect as if no such failure to enforce had occurred.

## **23. Severability and Survival**

Each provision of this Agreement is severable from the others. Should any provision of this Agreement be found invalid or unenforceable, such provision shall be ineffective only to the extent required by law, without invalidating the remainder of such provision or the remainder of this Agreement. Further, to the extent permitted by law, any provision found invalid or unenforceable shall be deemed automatically redrawn to the extent necessary to render it

valid and enforceable consistent with the parties' intent. The terms and conditions hereof shall survive the termination of this Agreement.

#### 24. Notice

Where required by this Agreement, notice shall be made in writing by delivery to the address set forth below. Email notification is acceptable.

**A – 4, Transfer of Funds to CD**

**ISSUE:** Whether to transfer \$250,000 currently held by the Lake County Treasurer to a Certificate of Deposit held by a private bank.

**RECOMMENDATION:** SWALCO staff recommends approval.

**BACKGROUND:** Lake County maintains funds for the agency and all our transactions are conducted under the County's accounting system. The cash balance in our fund ranges from \$600,000 to \$700,000 and while we are paid interest on the cash balance it is far below the market rate for CDs. Staff recommends we transfer \$250,000 from the County Fund to a private CD, likely the bank that holds our current CD. This will still leave plenty of money in the fund for any cash flow issues that might occur.

## **A – 5. 2024 Legislative Policy**

**ISSUE:** Whether to approve the Legislative Policy for 2024

**RECOMMENDATION:** SWALCO staff recommends approval.

**BACKGROUND:** The 2024 Legislative Policy is broken into Standing Policies and Top Priorities for the coming year. The Standing Policies were slightly modified from last year for updating purposes. The Top Priority is limited to one bill in the 2024 session for single use and rechargeable batteries. The agency was part of a working group that developed the EPR bill along with SWANCC, IRMA, IMA, the waste industry and the battery industry group (PRBA). The bill has been filed and we are awaiting a bill number. The IL Environmental Council has given its ok and we are working on making changes to the bill requested by the IEPA. There will be an amendment filed on the bill to make those changes for the IEPA.

Senator Johnson introduced an interesting bill, SB 2816, which would ban food scraps from being landfilled. This is a far-reaching bill and several states have enacted similar legislation. We have reached out to the Senator and plan to schedule a meeting with her and assist with advancing more stakeholder talks. A bill like this will take at least another year to try to craft a compromise. Momentum is growing to reduce methane emissions from landfills and food scraps account for nearly 60% of methane emissions according to a recent USEPA study. As founders of the IL Food Scrap & Composting Coalition we have worked hard to divert food waste from the landfill, and lead the State in curbside organics collections programs, along with the county jail program, numerous grocery stores and restaurants in the county.

The environmental community is pushing hard on SB 85 (bottle bill) and SWALCO is actively engaged in discussions on the bill. We have a standing policy to oppose bottle bills due to the impact on our current curbside recycling programs and the fact the unredeemed deposits (estimated at \$175,000,000 per year) all go to the distributors. There is significant opposition from the waste industry, retailers and beverage producers to the bill at this time. It is expected this bill will get pushed to the 2025 session due to its financial impact.

## 2024 LEGISLATIVE POLICY – STANDING POLICIES

The Solid Waste Agency of Lake County (SWALCO) is a Municipal Joint Action Agency established to implement the Lake County Solid Waste Management Plan. SWALCO is comprised of 43 Lake County municipalities, the County of Lake and the Great Lakes Naval Base. SWALCO's Board of Directors established the Legislative Committee to develop a legislative policy for ultimate approval by the Board of Directors. The Legislative Committee implements the approved policy.

The following are SWALCO's standing or existing policies in key subject areas, which have been divided into state and federal levels.

### STANDING LEGISLATIVE POLICY

SWALCO's legislative policy will be communicated to our elected representatives and will be used to provide input to organizations which SWALCO, or its members, are affiliated (for example: National Association of Counties, US Conference of Mayors, the Solid Waste Association of North America, Illinois Counties Solid Waste Management Association, Illinois Recycling Association, Lake County Municipal League, Northwest Municipal Conference and the Illinois Municipal League).

The following is a more detailed discussion of SWALCO's policy stance on key state and federal solid waste policy issues.

#### *State Level*

##### **1. ISSUE: INFORMATIONAL SUPPORT FOR OUR STATE DELEGATION**

The SWALCO Legislative Committee and staff will coordinate with the Lake County legislative delegation in reviewing legislative initiatives.

#### **Discussion**

SWALCO stays in close contact with its legislative delegation through ongoing discussions with our lobbyist, Mike Grady. SWALCO staff and members of the Legislative Committee will strive to meet in person with all members of the legislative delegation in the coming year either through our partnership with the Lake County Municipal League, attending special meetings convened by legislators, or visiting with them while in Springfield.

It is also important for SWALCO to support its delegation on an on-going basis regarding issues as they arise in Springfield. The state representatives often do not have the staff required to complete detailed assessments of issues. However, this is an area where the Agency can assist its legislators.

## **2. ISSUE: PRODUCT STEWARDSHIP LEGISLATION**

SWALCO will support legislation that fosters responsible product stewardship and responsibility. SWALCO will engage with manufacturers and other stakeholders to enact legislation that reduces the health, environmental and social impacts of consumer products throughout their life cycle, with the ultimate goal of responsibly managing products after their useful life to conserve resources and protect the environment and human health. This activity commonly known as “Product Stewardship” is very common throughout Europe and Canada and to a lesser degree in the United States where over 34 States have passed laws covering 12 different product categories (e.g., electronics, paint, mercury thermostats, and mattresses). One definition of Product Stewardship developed by the Product Stewardship Institute is, “the act of minimizing the health, safety, environmental and social impacts of a product and its packaging throughout the product life cycle, while maximizing the product’s economic benefits. The producer of the product has the greatest ability to minimize the adverse impacts; however, other stakeholders, such as suppliers, retailers and consumers, also play an important role. Stewardship can be either voluntary or required by law.”

### **Discussion**

In the past several years SWALCO has been active on Extended Producer Responsibility (EPR) laws for electronics, paint, pharmaceuticals, packaging and carpet.

## **3. ISSUE: LOCAL SURCHARGE**

Support amending the Illinois Environmental Protection Act to either eliminate exempting wastes from state and local fees imposed by units of local government (\$1.27 per ton) or increasing the fee in order to provide a more stable funding source for the agency. The authority to impose a local fee on the two in-county landfills has been a key funding source for SWALCO since its inception. Currently, the local surcharge fee represents approximately 65% of the funding for the Agency’s annual budget. Approximately 25% of the waste accepted at the landfills is exempt from the local surcharge, and the local surcharge fee of \$1.27 per ton has not been increased since the enactment of the Solid Waste Management Act in 1986. Further, SWALCO splits the local surcharge fee with the Lake County Health Department, with SWALCO receiving 75% of the fee and the Health Department the remaining 25%.

### **Discussion**

The Task Force on the Advancement of Materials Recycling that SWALCO was appointed to in 2013 did not take a position or offer recommendations regarding the local or state surcharge fees in its 2015 final report to the General Assembly. In addition, the Solid Waste Management Fund, where the State fees are deposited, has been swept in the past and the potential for additional sweeps of the money continues to exist. The agency

and Lake County filed lawsuits regarding the payment of the local surcharge fees in 2022 and those cases are currently pending.

#### **4. ISSUE: FOOD SCRAP COMPOSTING**

The Agency will actively support legislation that promotes and supports the marketing of compost or enhances the market demand for compost derived from landscape waste alone or commingled with food scraps.

##### **Discussion**

With the passage of SB 99 in 2009 (which SWALCO supported and worked hard to see enacted) significant barriers to the development of food scrap composting sites were removed. SB 99 and the legislation passed in 2015, 2016 and 2017 have provided the necessary regulatory changes to further encourage the diversion of food scraps and other organics from the landfill. Thirty SWALCO members now have provisions in their hauling contracts to allow the commingling of food scraps with landscape waste during the 8-month landscape waste season, five of which include year-round food scrap collection. The concern is that compost sites in and near Lake County are currently not able to sell all the final compost product they produce and end up land applying a substantial portion of it on farmland owned by the site operators. This lack of markets impacts the compost sites' willingness to accept more organic material if they are having a hard time selling what is currently accepted.

#### **5. ISSUE: RENEWABLE ENERGY FROM MSW SOURCES**

Support the designation of municipal solid waste (MSW) derived energy as a renewable energy source. SWALCO may, on a case-by-case basis, support the establishment of renewable energy goals/requirements as a percentage of total energy output. This may also include support for tax credits and other incentives, including greenhouse gas offset credits that provide financial and/or environmental incentives for the development of renewable energy from MSW sources.

##### **Discussion**

Under current Illinois law, energy derived from municipal waste from non-landfill related uses does not count as a renewable energy source and therefore cannot be counted toward the 25% renewable portfolio standard per Illinois law (25% by 2025).

#### **6. ISSUE: POLLUTION CONTROL FACILITIES**

Oppose changes that affect the local authority's control over the siting of pollution control facilities.

##### **Discussion**

SWALCO firmly supports the current practice of having local units of government approve or deny the siting of pollution control facilities within their jurisdictions. This

law has proven to be successful in Illinois. Any attempt to tamper with local control will be opposed by SWALCO. However, minor changes to the law that help streamline or clarify the process (often due to case law) will be evaluated on a case-by-case basis.

## **7. ISSUE: LANDFILL MATERIAL BANS**

Oppose the banning of individual materials from landfills unless a viable alternative disposal technology and funding is available.

### **Discussion**

Waste bans have been used previously to eliminate landscape waste, white goods, electronics and oil from municipal solid waste landfills. These bans have reduced the amount of material going to landfills. However, the infrastructure needed to support an alternative disposal plan is rarely in place. SWALCO believes that a two-year period is required to ban material from a landfill and to set up the alternative disposal technology. In this interim period, the state agencies can address the alternative disposal methodologies needed to handle the banned material.

## **8. ISSUE: ENVIRONMENTAL FEE TRANSFER**

Oppose the transfer of any state fees imposed on municipal solid waste to offset any shortfall in general fund revenues.

### **Discussion**

The State applies two fees on waste accepted at landfills: a Subtitle D fee (this refers to the portion of the federal law known as the Resource Conservation and Recovery Act, which regulates municipal waste landfills) and a solid waste fee. The Illinois Environmental Protection Agency, Bureau of Land (BOL) uses these fees for its programs. These fees are used for enforcement grants, which enable Lake County and others to inspect solid waste facilities. It is imperative that these fees stay in the BOL and not be used for other State purposes. SWALCO does not support the transfer of fees to the general fund and supports the expansion of the enforcement program to other Illinois communities.

SWALCO is reliant on our agreement with the Illinois Environmental Protection Agency for funding the disposal of the household chemical wastes we collect in our program. Securing and maintaining funding for this agreement is of the greatest importance to SWALCO.

## **9. ISSUE: DEPOSIT LEGISLATION**

Oppose the imposition of a deposit on beverage containers. A \$0.05 or \$0.10 fee on beverage containers will negatively impact our recycling programs by reducing the revenue anticipated by the recycling centers and creating a fee on residents. One exception would be deposit legislation that focused on glass containers only, such a

deposit would help reduce glass at the recycling plants, which makes the plants more profitable by removing a material that is hard on processing equipment and has a negative value after accounting for processing costs.

### **Discussion**

Eleven states have enacted this deposit legislation. Hawaii adopted a deposit system in 2002. The remaining states adopted a deposit system prior to 1987. Generally it is aimed at reducing roadside litter by creating a financial incentive as well as recycling discarded materials. New York experienced a 30% reduction in roadside litter with their bottle bill.

Deposit legislation can expand access to the recycling system to all residents, but handling of deposit containers, either through retail stores or redemption, is an increased burden from a transportation and space standpoint - such as additional trips by residents to redeem containers and space required by retailers to store deposit containers. This financial burden on retail stores may be partially offset by the fees imposed by the deposit. The deposit is an additional fee on residents when they fail to redeem their containers. Curbside recycling represents a convenient way for residents to recycle their beverage containers.

If high value containers such as aluminum cans and PET bottles are removed from the recycling stream the recycling plants' revenue from commodity sales will be decreased substantially. Most SWALCO members have a change in law provision in their contracts that would in theory allow the haulers to come back and ask the members to make up the difference by raising rates. Preliminary estimates are it could raise rates by \$1 per household per month or more.

## **10. ISSUE: LEAF BURNING BAN**

The Agency will support a leaf burning ban bill, which provides for local control of burning ordinances.

### **Discussion**

Landscape waste is prohibited from being disposed of in landfills. Therefore, property owners must compost/mulch leaves at home, subscribe to a service for collection (which costs money) or burn them. Many member communities have banned or restricted the burning of leaves within their communities, while other communities have decided to not restrict the burning of leaves. Most recently in 2022 Lake County enacted restrictions on the open burning of leaves and other woody materials in unincorporated Lake County.

Burning leaves creates particulate emissions and causes the release of chemicals in the burning process. Many residents suffer respiratory distress as a result of this process. Leaf burning is a significant air pollution hazard and may be an increased health risk to humans. The Agency will consider supporting a leaf burning ban bill which provides for local control of burning ordinances and does not negatively impact local burning ordinances already enacted by SWALCO's members.

## ***Federal Level***

### **1. ISSUE: INTERSTATE WASTE**

Support federal legislation which recognizes and "grandfathers" current interstate waste transport and disposal. Any bill that limits the future importation or exportation of waste should be evaluated to assess its impact on SWALCO's members before a final policy position is taken.

#### **Discussion**

Midwest states do not want to be considered dumping grounds for east coast or Canadian generated waste. Many communities, however, signed agreements to accept waste from outside of their state when their local landfill was developed. They benefited in this arrangement by receiving host fees for this waste. Several states, primarily Michigan with its concerns over waste imports from Canada, have attempted to enact federal legislation to limit or restrict the flow of waste from other states and/or countries. In Illinois we recognize that a significant quantity of Chicago metro waste is transported to landfills in Wisconsin, Michigan and Indiana. Any federal attempt to legislate the flow of waste must be closely scrutinized and evaluated before a position can be taken.

### **2. ISSUE: FLOW CONTROL**

Take no action on flow control, other than to work with other solid waste and municipal organizations to monitor the progress of any flow control legislation and ensure that local governments can institute franchise refuse collection and continue to act as a market participant to direct their waste and/or recyclables to facilities pursuant to competitively bid contracts.

#### **Discussion**

The US Supreme Court has upheld the right of communities to enact flow control by acting as a market participant. The Court went further with its April 30, 2007 decision in the *United Haulers v. Oneida-Herkimer Solid Waste Management Authority* case where the Court sustained the flow control ordinances of the Waste Authority. The Court held that directing waste or recyclables to publicly owned facilities was constitutional. The Court has now created a public-private distinction with respect to the Commerce Clause of the U.S. Constitution.

This means that SWALCO has the legal authority to direct its waste and recyclables to publicly owned disposal sites and recycling centers. What isn't clear in the decision is what ability public entities have to direct materials to privately owned or operated facilities. Regardless, SWALCO does have the authority to act as a market participant and direct materials to facilities as part of competitively bid contracts.

### **3. ISSUE: RENEWABLE ENERGY FROM MSW SOURCES**

Support the designation of municipal solid waste (MSW) derived energy as a renewable energy source. SWALCO may, on a case-by-case basis, support the establishment of

renewable energy goals/requirements as a percentage of total energy output. This may also include support for tax credits and other incentives, including greenhouse gas offset credits that provide financial and/or environmental incentives for the development of renewable energy from MSW sources.

## **Discussion**

Methane gas energy production is an example of energy production from waste sources. The primary method of waste management in Lake County is landfilling. Both in-county landfills collect and generate energy from methane gas. This capability is facilitated through tax incentives. It is also a source of renewable energy production.

Also of interest is energy derived from alternative waste management technologies including anaerobic digestion and MSW gasification. Both technologies are well proven with other feed stocks, but have yet to be utilized for MSW in the U.S. due to unfavorable economics and the U.S.'s continued reliance on landfilling. Several alternative technology projects are proceeding in both California and Florida. Essential to the economics of these projects is the designation of the energy as a renewable energy source. Large utilities are now searching for renewable energy projects and are often willing to pay a premium for the energy. These projects also have the potential to reduce the amount of greenhouse gases (GHG) emitted in the production of energy, especially as related to coal power plants.

## **4. ISSUE: PRODUCT STEWARDSHIP AND PRODUCER RESPONSIBILITY**

Support legislation that fosters responsible product stewardship and producer responsibility. Most attention is currently focused on the electronics industry. SWALCO supports a national policy, but in the absence of a national policy will support a state-based program (please refer to the state level discussion).

## **Discussion**

Product stewardship is a product-centered approach to environmental protection. Product stewardship calls on all those in the product life cycle--manufacturers, retailers, users, and waste managers --to share responsibility for reducing the environmental impacts of products.

Product stewardship recognizes that product manufacturers should take on new responsibilities to reduce the adverse environmental impact of their products. However, all participants in a product life cycle, including retailers, consumers, and waste managers have important roles to play in working in cooperation with product manufacturers to develop the most workable and cost-effective solutions.

From a solid waste manager's perspective, product stewardship refers to the actions that should be taken with respect to product design, reuse, collection, recycling and disposal in order to avoid adverse environmental impacts from the disposal of the product.

Manufacturers must design their products to facilitate disassembly and recycling.

Consumers must be educated on how to properly dispose of products. Education can be approached through information developed by manufacturers and provided to consumers through product stickers, operation manuals and advertising. Most importantly, an

infrastructure must be developed to properly and responsibly handle the product if it's diverted from the municipal solid waste stream

## 2024 LEGISLATIVE POLICY – TOP PRIORITY

The Solid Waste Agency of Lake County (SWALCO) is a Municipal Joint Action Agency established to implement the Lake County Solid Waste Management Plan. SWALCO is comprised of 43 Lake County municipalities, the County of Lake and the Great Lakes Naval Base. SWALCO's Board of Directors established the Legislative Committee to develop a legislative policy for ultimate approval by the Board of Directors. The Legislative Committee implements the approved policy.

SWALCO has developed two documents related to its legislative policy: 1) 2024 Legislative Policy – Standing Policies, and 2) 2024 Legislative Policy – Top Priority. The Standing Policies represent SWALCO's current viewpoint on key solid waste related issues on both the state and federal levels. This document, Top Priority, outlines legislation the Agency intends to pursue in 2024.

### **Top Priority for 2024**

#### **1. Single Use and Rechargeable Batteries, Extended Producer Responsibility**

Over the fall of 2023 SWALCO worked with a group that included SWANCC, the National Waste and Recycling Association, the Illinois Manufacturers Association, the Illinois Retail Merchants Association and the Rechargeable Battery Association (the national association that represents large battery producers) to develop a draft EPR bill modeled after legislation enacted in Washington in 2023. Based on the consensus on the bill so far it appears it may have a chance of being enacted in the upcoming 2024 legislative session. If enacted it would expand the battery collection network in Lake County to more than 20 collection sites in addition to the expansion of SWALCO's collection of batteries at HCW events. The law would ultimately collect all batteries less than 25 pounds (would not include larger batteries from e-bikes or e-cars) that are loose or easily removed from both the residential and commercial sectors. Embedded batteries from toys, vapes, etc. are not included in the scope of the law. It would become effective in January 2027 if enacted as proposed.

Vermont has had the longest running EPR program for batteries, but its law is for single use, primary batteries only and New York has had a law since 2010 for rechargeable batteries only. Washington DC just implemented its law in 2023 for both single use and rechargeable batteries.

The battery industry has created a 501 (c) (3) called Call2Recycle that administers the programs in Vermont, New York, DC and soon to be Washington. The industry has been proactive in its approach to EPR legislation and has shown an ability to successfully implement laws.

## **I – 1. Project and Program Updates**

**BACKGROUND:** The following are updates on several projects and programs we are currently working on:

1. The complaints against the landfills continue, several depositions were held in January including the landfill's witness for the Zion LF. We still have to depose several more witnesses representing the two landfills. Lake County staff, Patrice Sutton and Matt Meyers, also testified on behalf of the County's case against the landfill.
2. The MRF project continues as each of the three proposers were given an opportunity to submit an amended proposal, two of the three did provide amended proposals. Based on the final proposals we have a company staff is ready to recommend we enter into contract discussions with, more specifics will be provided at the meeting.
3. Discussions continue with Reynolds staff regarding launching its Hefty ReNew bag program in Lake County. Under this program, difficult to recycle plastics such as film, chip bags, pet food bags, styrofoam, etc. can be placed into an orange bag made by Hefty/Reynolds and put into the recycling cart. Reynolds has a MRF expert on their team and he is meeting with three of the MRFs that indicated an interest in the program – LRS, Groot and Resource Management. The key to the project moving forward is Reynolds entering into agreements with the MRFs to cover the cost of processing the bags. The goal is to have those agreements in place prior to the SWALCO BOD meeting on April 11<sup>th</sup> where we would formally announce the program. Due to the need to get the ReNew bags on the grocery store shelves in the County (goal is Jewel at least) we won't be able to launch the program until the fall of this year.
4. SWALCO is working with SWANCC, DuPage County, Kane County and the battery industry on a battery education campaign we hope to launch in February. There will be a website dedicated to explaining battery types and options for safe management of batteries. Under the proposed battery bill, HHW sites like ours will become extremely important collection sites for the medium and larger rechargeable batteries, and damaged batteries. We have the site, permit and staff expertise to fill that need.
5. Joe Martino submitted a second grant request under the IEPA's sharps program to help cover the cost of the sharps we generated from our pharmaceutical program. It is another \$35,000 grant. Joe and I met with Lake Villa and Gurnee about transitioning them into the sharps program (they have WM as their hauler and had a sharps program with WM, neither renewed their contract with WM).
6. Pete Adrian submitted a grant application for a \$10,000 planning grant from IEPA, it was awarded and will help pay for our consulting costs for the plan update.
7. Pete also submitted the final report to the USDA bringing to a conclusion the 2 year program that was funded by the grant.
8. Merleanne continues to expand the textile collection network and is leading the programming for the IFSCC's celebration of International Compost Awareness Week (ICAW) which was a great success in 2023 with more to come in 2024.
9. Amy Bartemio has been working with the county on an update to our website. We are also working with Tracy Bugh, Recycle by City creator, to increase traffic to our website on proper recycling and composting but also all our other great programs.
10. We met with the Council of the Great Lakes Region (CGLR, we are a Knowledge Partner on CGLR's Circular Great Lakes initiative) in January to prepare for the second year of collecting boat film wrap from marinas in Lake County and Chicago. Last year we collected over 20,000 pounds of boat film warp from approximately 500 boats. We hope to sustain and

grow the program. The meeting included potential new collection efforts in Milwaukee, Detroit and Lake County, IN.

11. Staff assisted Lake Villa, Lake Villa Township and Gurnee in the past two months with residential hauler procurement. All three entities selected LRS. Groot has been competitive and WM has not. We are typically down to two companies that are actively competing for the contracts, much different than as recent as 5 years ago.
